81.1(a) Removal Actions; Refiling Motions	Requires that any motions pending in state court be refiled separately on this court's docket, and that any responses to such motions also be filed or refiled separately on this court's docket in accordance with LR 7.1.
83.2(b)(1)(B) Admission to Bar of this Court; Supporting Affidavit	Changed the rule to only require an attorney seeking to be admitted pro hac vice to provide the year(s) of admission to other bars.

Civil Form 3 Extending Deadlines in Discovery Plan	Removed duplicate entry for "Discovery Completed."
Civil Form 5 Protective Order	Edited paragraph 4(d).
