**PROTECTIVE ORDER**

Pursuant to this Court's authority to "protect the jurisdictional status of a party or witness who is reluctant to come to the forum state by issuing protective orders," Northern Light Tech., Inc. v. Northern Lights Club, 236 F.3d 57, 63 (1st Cir. 2001), it is hereby ORDERED:

1. No plaintiff in an existing C-Qur hernia mesh case against Getinge AB may, in an effort to establish personal jurisdiction, serve process on Anders Selander individually or as the corporate representative of Getinge AB, when Mr. Selander is present in the United States as the 30(b)(6) designee of Getinge AB for purposes of preparing for and attending the August, 2018 Getinge AB 30(b)(6) deposition.

2. No plaintiff in an existing C-Qur hernia mesh case against Getinge AB may, in an effort to establish personal jurisdiction, serve process on Peter Hjalmarson, individually or as the corporate representative of Getinge AB, when Mr. Hjalmarson is present in the United States as the 30(b)(6) designee of Getinge AB for purposes of preparing for and attending the July, 2018 Getinge AB 30(b)(6) deposition.

3. No plaintiff in a prospective C-Qur hernia mesh case related to those currently pending against Getinge AB may, in an effort to establish personal jurisdiction, serve process on either


Mr. Selander or Mr. Hjmarlson, individually or as the corporate representatives of Getinge AB, when Mr. Selander and Mr. Hjmarlson are present in the United States as the 30(b)(6) representatives of Getinge AB for purposes of preparing for and attending their Getinge AB 30(b)(6) depositions.

4. Plaintiffs may not use the fact that the Getinge AB corporate representatives appeared for deposition in the United States as a jurisdictional contact or otherwise in furtherance of Plaintiffs' opposition to Getinge AB's forthcoming Motion to Dismiss for Lack of Personal Jurisdiction.

5. Getinge AB is granted process immunity against in-person service of process upon either Mr. Selander and Mr. Hjmarlson in unrelated matters when they are present in the United States as the 30(b)(6) representatives of Getinge AB for purposes of preparing for and attending their respective Getinge AB 30(b)(6) depositions, consistent with N. Light Tech., Inc. v. N. Lights Club, 236 F.3d 57, 63 (1st Cir. 2001).

The parties, including Plaintiffs' Executive Committee, have agreed to the terms of this Protective Order.
